As artists are increasingly censored, imprisoned, restricted from moving freely across borders, tortured, or even killed, it is more critical than ever that we safeguard the right to artistic freedom and zealously champion the courageous artists who exercise it.

To this end, AFI directly assists artists who have experienced persecution, censorship, or other restrictions on their freedom of expression, and supports artists who have demonstrated a commitment to advancing progressive social change and fundamental human rights.

We work with immigrant artists to champion art produced in exile, advance creative cultural exchange, improve conditions for artists in their home countries, and safeguard their ability to express themselves creatively through the arts.

AFI is seeking a contract grant writer to assist staff with strategic research and grant writing during the upcoming Summer 2022 grant cycle. AFI relies on institutional grants to fund its important work safeguarding artistic freedom and advancing fundamental human rights. We are looking for a highly-motivated, resourceful, detail-oriented, articulate, versatile, and socially conscious individual to join our team on a part-time, contract basis. The ideal candidate is committed to human rights and the arts, is comfortable self-directing in a dynamic environment and can work well as part of a small but fast-paced team.

Responsibilities include, but are not limited to:

- Researching grant opportunities in the areas of arts, culture, human services and human rights for 2022 and 2023.
- Presenting potential grant opportunities to the AFI team.

- Developing cohesive and persuasive narratives, articulating AFI's mission and achievements and detailing the proposed project, while tailoring narratives to match the institutional funder's interests and centering the eligibility criteria throughout.
- Developing project budgets, with input from AFI staff.
- Undertaking a detailed assessment of grantmaking policies, terms and conditions, reporting and compliance.
- Preparing interim and final reports in respect of previously awarded grants.

This position will be conducted remotely.
